## VENDOR MEMBERSHIP PROGRAM

The Society of County Human Resource Professionals of Pennsylvania (SCHRPP) began January 1, 2010 to support the national Society for Human Resource Management (SHRM) initiative to "advance the profession" of human resources (HR), particularly in Pennsylvania counties by improving the professional development of county HR personnel and enhancing the services available to county HR personnel. SCHRPP's membership consists of Pennsylvania county and county related entity HR personnel, and chief clerks and other personnel in counties without designated HR personnel. The goals of SCHRPP are:

- To be the primary source for information and services for Pennsylvania county HR personnel
- To provide industry leading conferences, training and resources for Pennsylvania county HR personnel
- To provide legislative advocacy on HR and employment related policy
- To follow the standards of a chapter of the Society for Human Resource Management (SHRM)\*

*\*NOTE: SCHRPP is not a chapter SHRM. SCHRPP's bylaws model those required for a SHRM chapter.*
